FIRST AID:

DIRECTIONS FOR USE

Remove lid. Pull towel from center of the roll and thread through underside of lid. Pull towel at 90° angle. Snap hinged cap back into place so towels stay moist.

Do not allow children to handle this product. Do not apply over cuts, wounds or irritated skin. Do not apply to eyes and mouth and do not apply to the faces of young children. Do not apply directly on face. Apply sparingly around ears. Use just enough repellent to cover exposed skin and/or clothing. After returning indoors, wash treated skin with soap and water. Wash treated clothing. Use of this product may cause skin reactions in rare cases. If you suspect that you or your child is reacting to this product, wash treated skin and call your local poison control center. Have the product container or label with you when calling a poison control center or doctor, or going for treatment.
